Deck Attachment: Minimum 22 gage steel deck shall be secured 6" o.c. to structural supports spaced a

maximum distance 5' o.c., with one (1) $\#12 \times 1-1/4$ " HWH self drilling screws fastened at the bottom of each flute (6" o.c.). Deck sidelaps shall be fastened 12" o.c. with $\#14 \times 7/8$ /"

HWH self drilling screws.

Insulation: Minimum 4" - 6" thick approved rigid polyiso insulation with current NOA having a

minimum 25psi compressive strength fastened with approved #14 pancake head screws long enough to penetrate the steel deck through 3" diameter insulation plates. Fastening density shall be in compliance with applicable Building Code and Roofing Application

Standard RAS 117.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum 4"

side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and fasteners, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the

roll or any approved underlayment having a current NOA.

Fire Barrier Board: Any approved fire barrier having a current NOA. Refer to a current fire directory listing for

fire ratings of this roofing system assembly as well as the location of the fire barrier within

the assembly. See Limitation #1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS 133

and with the current published installation instructions and details in Berridge

Manufacturing Company's current published installation manual.

Metal Panels and

Accessories:

Install the "Cee-Lock Panel" and accessories in compliance with Berridge Manufacturing Company's current, published installation instructions and in compliance with the minimum

requirements detailed in Roofing Application Standard RAS 133.

Each roof panel shall be secured along the male rib with approved continuous clips. Clips shall be attached to the substrate with one (1) DPI Concealor by TFC, #14-13 corrosion resistant screw of sufficient length to penetrate through the bottom flange of the steel deck a minimum of $^{3}/_{4}$ " at a spacing listed below in Table A. The female rib of panel is installed

over the male rib of panel.

- **3.** Panels may be rolls formed in continuous lengths from eave to ridge. Maximum lengths shall be as described in Roofing Application Standard RAS 133
- 4. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.




5. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.






